

## **A Case of Schizophrenia**

A woman around 32 years was brought for treatment. She was diagnosed with schizophrenia. She kept on crying and was not able to answer the questions asked from her. Her sister said that only thing which she has been doing since days is crying. She just kept mumbling to herself. Her sister brought her to her parents place as she was tortured by her husband.

### **Gist of the case ( Verbatim )**

My husband does not allow me to speak to my child. Even if he calls everyday, he won't let me see my son. He will say that his phone does not allow video calls.

He wants me to admit that I have an affair, and I say yes even if I don't have one. I accept, because he tortures me. I accept whatever he says. I will do whatever he wants. I even cut off my contact with my parents because of him.

He hits me, hits me in front of the kid, he abuses me. Now the kid does the same, looking at him, he abuses the father.

The kid is 5 years old.

My son is very young. There are other kids in the family too. But no one stops my husband from hitting me. They should stop him but they don't.

Throwing stuff, even though I'm healthy, he pulls and then pushes me. He slaps me to make me agree to things. If he's coming from somewhere, he'll step on me. If we're sleeping together and the kid is sleeping in the middle, he'll kick.. I tolerate a lot of things because of the kid.

The other kids at home, they don't have a father.. They have 3 kids.. a mother in law, a brother in law, sister in law's married. We have to look after them too. But if I say anything to him, like to spend less on his family, he hits me.

If I provide my son with the "big" things, he'll want more and my husbands provides him with everything he wants. That is not good for a child.

I want to control my son, but my husband wouldn't allow me to do so.

I don't want to meet my mother in law. They don't treat my husband well. I can't speak in between. He says I will do whatever I want and I have to accept whatever he wants me do.

I had stopped eating only, when they forced me, I ate. My sister came and took me to my parents house.

While this was happening, I was having problems mentally, I had a lot of trouble. I was not able to go out, not able to meet anyone, I stopped going to the school. I was not able to talk to anyone from home directly. I had to lie about me not going to the school. I was not in the condition to go to the school and earn.

My ATM got blocked. My husband used to use mine, I did not use his. Because we used to carry it together. I never needed it. I could not use money which I had earned.

I came to my parent's place, without telling my husband. My parents were so troubled that I did not call them up.

I did not feel like talking to anyone.

(Her sister said she never ever shared that she was tortured.)

I used to talk to everyone in the colony. He must've felt something, he started doubting that I was having an affair. I used to talk to everyone. He started worrying and so I stopped talking to people. I started staying at home. Kids were with me. But I didn't talk to them much. I used to do so much earlier but then I stopped. I used to do everything for my husband, whatever he liked. Like if I was cooking and it got burnt even a little, I made another one for him. He didn't like food prepared by me at all.

My husband had a doubt that I must've stopped somewhere on my way. I used to say why would I stop in such a distant place. I wanted to come home as soon as possible. He was like when did you leave..

I had fallen sick. It had been 3 years. I'm living here since 2 years.

No one was there to work since 4 months so we only used to work. I got typhoid and was weak. I said I've become weak, call someone to work and then they did.

When they tortured me, I started bleeding excessively during menses. It continued for 1-1.5 months. It used to stop when I was happy. But then it started again.

My sister in law took me to a black magic person. And my husband had problems with that too. He said that I'm so educated and I'm still doing this so I stopped going to him.

My husband spends money on his family. He has maintained his standard. Once I spent Rs 10,000 on my child (a vicious smile), he tortured me.

He used to call me and I don't know what has happened with my phone, but it continuously says busy.

Even for teaching.. for my job, to explain something, I download it and show it to my students.

### **She mumbled things like**

- Do you think only he has the right to have an affair?

- Even I can have an affair
- It serves him good.
- I want to be with my son for 200 years.
- I want a rebirth.
- I want to be born as a tortoise.
- A tortoise has a longer life. It can stay with its child for a longer time for 200 years.

**Her main concern**- is that she wants to meet her child but he is not allowing her to meet him.

**Certain things to look at:**

- She says she admits that she has an affair because she has a fear of him hitting her. ( It should've been the other way round )
- She said she asked her husband to cut down on their extra expenses and not provide everything her son desires for, yet she still bought clothes for him worth 10k, which is huge.( She had a vicious smile when she said this )
- She asked if only he has the right to have an affair, this shows a tendency to take revenge.
- She said that she does not know what is wrong with her phone, it is continuously showing busy. Hes husband always finds her phone busy.
- (Phone wouldn't show it busy just like that, it means she is talking to some one for long hours and she is denying. )

**Follow up - 2 doses 1M potency was given**

**1 st Follow up after a week**

**She came smiling . Her orientation was better.  
She was not mumbling  
Her eye contact was good,.  
She answered with a smile  
She said all is good.**

**2 nd Follow up after 15 days**

**She came smiling.  
She was now ready to go back to her husband.  
She was less worried about her child.  
She would talk to them on phones.**

**Follow up after three months**

**She was happy.**

**There was no complaint about being tortured.**

**Follow up after three years**

**She is staying with her husband and in laws happily**

### **Analysis and Evaluation**

#### **KINGDOM ANIMAL**

There is Me / You , A Victim and a perpetrator is seen in the case.  
Also because she said he tortures me, he hits me..  
“Someone is doing something to me”-

She has also planned a revenge in her own small way.

Once you come to Animal Kingdom ,the next step is to see Is it an invertebrate or a vertebrate.
